Professional Incentive Program for the Office Professional

The California Association of **Education Office Professionals** offers the Professional Incentive Program (PIP). It is time to invest in yourself. All educational office professionals are eligible to participate. It does not matter where you are in your professional journey. They have multiple points of entry. Whether you are in college, vocational training, or by work experience or community service, CAEOP knows you have accomplished a great deal already in your professional life. The PIP program will assist you by providing a framework to guide your next steps.

You can receive a certificate in two categories. Track One provides different levels of recognition for individuals pursuing a degree or coursework. Track Two is based on years of work experience, inservice completed, and association responsibility. All certifications from workshops, trainings, and presentations that you have attended count towards your certification. Please make sure you keep all your certificates and trainings attended in a folder. You will need to provide verifiable proof of attendance.

The Professional Incentive Program is endorsed by Chancellor, California State University; Chancellor, California Community Colleges; Association of California School Administrators; California Association of School Business Officials; and by the California School Boards Association

Employee Health Services

The Employee Health Services Unit is an integral part of the Human Resources Division. The staff consists of a medical director and three clerical employees and are available at 333 S. Beaudry Avenue, 14th Floor, Los Angeles, CA 90017.

Employee Health Services welcomed Dr. Rosa Mercado as Medical Director in September 2007. New to us, but not to the district, Dr. Mercado has worked for LAUSD since 1989 with Student Medical Services. Her expertise and knowledge make her an asset to our office. Employee Health Services provides direct medical services to almost 10,000 employees and medical consultation and guidance to many more.

Employee Health Services manages the Tuberculosis Compliance Program for all employees of the district. The medical director evaluates employees for "return to work," "fitness for duty," and reemployment. An appointment is required to see the medical director.

The office serves as medical consultants to our legal department, Office of Risk Management, and all staff

As of September 2008, the Employee Health Services no longer provides tuberculosis skin tests, Hepatitis B vaccines, or X-rays. These services will be available to all employees through their district paid health plans.

Employee Health Services encourages you to give priority to your health and well-being.

Contemplating "Service" Retirement

If you are planning to retire in a year's time, I suggest you request your documents now. This will give you time to read them, to understand them, and to ask questions. If you have more than a year, you have plenty of time to prepare. However, do not wait until the last minute.

Start by contacting the PERS Office, Sacramento, California, by telephone, call tollfree at 888.225.7377, Monday through Friday from 8:00 a.m. to 5:00 p.m. and someone will assist you; or you may order forms or publications 24 hours a day, 7 days a week, using their automated voice response system at the same telephone number.

You may schedule a Retirement Planning Workshop or Financial Planning Seminar as well (888.225.7377). (CalPERS Pub 43-2007.1.1)

If you are internet savvy, you may go on-line at the CalPERS on-line Web site at www.calpers.ca.gov and follow the prompts. You will need your social security number.

Important documents to compile:

- Official PERS Statement of Earnings This statement will show how much you have contributed and your approximate monthly income amount. To get this statement, please call 888.225.7377.
- Official PERS Retirement Options Packet -This package will offer you the different financial Options. To get this package, please call 888.225. 7377.

You Have Selected Service Retirement – A Few Steps to Begin the Process

- Set a retirement date
- Meet with your Manager / Director (Human Resource Representative)
- **Contact Employment Transactions** Personnel Branch for Resignation Form or HR Representative
- Complete form Select Resignation to Retire
- Resign the day before you retire -- for example, 12/28/07 to retire 12/29/07 The retirement date is 12/29/07.
- Classified Personnel Office 213.241.6300 or HR Rep.
- After you complete your retirement packet forms, send them to CalPERS to start the retirement process.
- Complete a Salary Discontinuation Form for any selected payroll deductions – for example, charities, optional life insurance,. Get this form from the Payroll Services Branch.
- Contact LAUSD Health Insurance Benefits regarding your Health Insurance Benefits

- package and your Tax Shelters. Please call 213 241 4262
- Disability Retirement for Classified Personnel, please contact LAUSD Classified Disability Retirement Section Division of Risk Management & Insurance Services at 213 241 2570.
- UTLA and AALA personnel, please contact State Teachers Retirement System at 800 228 5453 and Division of Risk Management & Insurance Services at 213.241.2569.
- Special Note: The Catastrophic Illness Donation Program, Division of Risk Management & Insurance Services is available to all employees of LAUSD who qualify. Please call 213.241.1619 for detailed information.
